The Office of Judicial Administration will submit your fingerprints and receive the report on your criminal history investigation. Applicants determined ineligible to serve as volunteers based on their criminal history background investigation will have the opportunity to verify their identity with the Office of Judicial Administration and to appeal this determination with the Chief Judge of the Judicial District of his or her designee. Applicants who do not provide fingerprints for criminal history background checks will not be approved to serve as CRB volunteers.
